MERCURY will set up a database categorising legal acts on external relations instruments in the framework of the European Community (EC) and the Common Foreign and Security Policy (CFSP) from a multilateral perspective. A first version of DATEX will be launched in January 2010, a final version will be available in December 2010.

MERCURY at the PSA Annual Conference 29 march-1 April 2010

The Political Studies Association Annual Conference will be held in Edinburgh from Monday 29 March --Thursday 1 April 2010. The PSA is one of the world's longest established political studies associations. It is celebrating its 60th anniversary this year and the conference promises to offer a very stimulating and attractive prgramme. In addition, the British International Studies Association will be joining the PSA this year, making it a joint conference.

The MERCURY team is submitting two MERCURY panel proposals:

The first panel will present its findings in three papers: (1) Conceptualism Multilateralism, (2) Competing Patterns of IR and (3) Developing the Doctrine of Multilateralism. The second panel will present four papers: (1) EU institutional set up in the cases of health and the CFSP, (2) Cooperation in the North – Multilateralism or Mess? (3) Externalising EU Market-Related Policies and (4) Externalising EU Immigration and Asylum.

Presentation of MERCURY Institutes

University of Edinburgh, UK, Mercury co-ordinator

The University of Edinburgh was ranked by The Times recently as number 20 in the world. It has an outstanding reputation, hosting (among others) the Europa Institute and the Institute of Governance. Its School of Social and Political Science has been involved in a number of collaborative research projects, including the FP6 Network of Excellence 'EU-CON-SENT' and the FP6 'Expanding the Knowledge Base of European Labour Migration Policies' (KNOWMIG). Edinburgh acts as the institutional head of MERCURY and leads Work Package I 'Mapping Modes of Multilateralism'. It also contributes to the other Work Packages. The academic team comprises five permanent staff, one post-doc, and one PhD student.



Dr Mark Aspinwall (Department of Politics and International Relations (PIR), is Project Coordinator. He is an expert in international and comparative political economy, and especially the domestic sources of government policy choice. He will work on the EU in the systems of regions, and is responsible for leading the administrative team.

University of Cologne, Germany

The University of Cologne represents one of the nine MERCURY partners. Within the project, the Jean Monnet Chair for Political Science of Prof. Wolfgang Wessels carries out four main tasks.

First, Cologne has been strongly involved with discussing and defining the basic analytical concepts to be used and refined throughout MERCURY's lifetime. In July 2009 a MERCURY workshop was organised in Cologne which produced working definitions and theses to be incorporated in the subsequent project research.

Second, Cologne leads the MERCURY work package which explores the question in how far the institutional set-up of EU external relations actually enables the Union to act multilaterally.

Third, together with the Stockholm International Peace Research Institute (SIPRI), Cologne takes care of the dissemination of MERCURY research results, for example via the project website (http://www.mercury-fp7.net).

Prof. Dr. Wolfgang Wessels has been Jean Monnet Chair for Political Science at the University of Cologne since 1994. He is chairman of the Executive Board of the Institut für Europäische Politik, Berlin and of the Trans European Policy Studies Association (TEPSA), Brussels. Since 1996 he has been visiting professor at the College of Europe in Bruges and Natolin. His priorities

in teaching and research include the political system of the EU, the role of the EU in the international system, the deepening and widening of the EU and theories about European integration. In 2007 the Jean Monnet Chair of Prof. Wessels was awarded the Lifelong Learning Award in Gold, the new flagship EU funding programme in the area of education and training, in the category 'Jean Monnet - European Studies'.
